"Social Thinking is a teaching framework for individuals aged preschool through adult that helps individuals learn to be better social thinkers and social communicators by breaking down social concepts into concrete, teachable formats using coordinated Social Thinking vocabulary, teaching tools and strategies." Sessions are individualized to a participant's needs and explore topic areas such as:

- Social problem solving
- Emotional regulation
- Perspective taking
- Organizational skills
- Executive functioning
- Attention
- Parent component to help generalize social skills into the home, school, and community
